

# Student Code of Conduct (DLI)

## Section 1 - Preamble

- (1) This Policy is effective from 4th September 2025.
- (2) The Student Code of Conduct (DLI) (the Code) outlines the standards of behaviour expected of all members of the Deakin University Lancaster University Indonesia (DLI) student community, ensuring a safe, respectful, and inclusive environment for academic and professional activities. It reflects the core values set out in the Deakin University Student [Code of Conduct](#) and Lancaster University [Student Charter](#), applied to the Indonesian cultural and legal context.

## Section 2 - Purpose

- (3) This Code sets out the standards of responsible and ethical behaviour and conduct expected of DLI students as part of contributing to a thriving, progressive, respectful and inclusive University community.

## Section 3 - Scope

- (4) This Code applies to all students of DLI. This Code should be read in conjunction with other policies and procedures set out in Section 6.
- (5) During the establishment of DLI, all policy, procedures and supporting processes will be regularly reviewed. In the establishment phase, defined as the first two years from when students commence DLI programs, any issues arising from the implementation of current policy, procedure or process will be referred to a jointly-convened Policy and Procedure Review Panel (PPRP). The PPRP will comprise designated academic and professional service representatives from the University Partners and the Office of the Rector. The PPRP will recommend an outcome best aligned with relevant principles and the best interests of any student(s) concerned, and will advise DLI on the future development of policy, procedure and supporting processes. During the establishment phase, the PPRP may make recommendations to vary any given policy only with endorsement from relevant University Partner governance processes. All policy and procedure will be subject to a full review at the end of the two-year establishment phase.

## Section 4 - DLI Commitment to Students

- (6) DLI is committed to:
  - a) offering students an outstanding education which prepares them for successful lives and careers;
  - b) welcoming student partnerships and feedback;
  - c) integrity and respectful, ethical behaviour in all aspects of learning, teaching and research;
  - d) promoting an environment where students feel safe, included and respected, and are treated with fairness and objectivity;
  - e) preventing sexual harm in our University community and continuously improving how we respond to, and support, those who have been affected;

- f) providing an environment where ideas are pursued with passion and where they can be challenged freely in accordance with the commitments set out in the Code for Upholding Freedom of Speech and Academic Freedom (DLI) outlined in Section 6.

## **Section 5 - Student Responsibilities and Obligations**

- (7) Students will:
  - a) undertake their academic work with integrity and honesty;
  - b) work cooperatively and collaboratively with other students, staff, associates and DLI partners;
  - c) educate themselves on, and comply with all relevant policies and with any codes of conduct and practice that apply at the course or professional level, including those of external partner organisations;
  - d) communicate with courtesy and consideration in person and online (including via email and social media);
  - e) responsibly exercise their rights to freedom of speech and academic freedom, and respect others' rights to their own opinions and beliefs;
  - f) uphold the health, safety, wellbeing and privacy of others in the University community;
  - g) engage in activities free from alcohol or drug impairment and will not put at risk the health or safety of other members of the University community
  - h) use University property, facilities and resources responsibly, in accordance with relevant policies and considering others' needs;
  - i) follow reasonable directions from DLI staff;
  - j) provide accurate personal details to the University, keep those details up to date, and read and respond to official University communications (including via Deakin email) in a timely manner.
- (8) DLI encourages students, staff or associates to raise any concerns related to the Student Code of Conduct with DLI by contacting the Campus Operations Officer (COO).
- (9) Alleged or actual breaches of the Student Code of Conduct are taken seriously by DLI and will be dealt with in accordance with the relevant policy and/or procedure as set out in Section 6.

## **Section 6 - Policy and Procedure**

- (10) This Code is a set of overarching principles to be followed. It is not an exhaustive list of behaviours. The Code cannot address all possible issues and scenarios which may be faced during a student's activities or study at the University.

## Section 7 - Definitions

(12) For the purpose of the Student Code of Conduct:

- a) **Associates:** contractors, consultants, volunteers, visiting appointees and visitors to DLI.
- b) **Staff:** members of the Academic or Professional staff, or persons holding Honorary or Affiliate/Conjoint appointments.
- c) **Student:**
  - i. a person enrolled in a program or module in DLI;
  - ii. a student of another higher education institution to whom the University grants rights of access to University premises and facilities;
  - iii. a candidate for an award of DLI whose work has been examined or assessed but on whom the award has not been conferred;
  - iv. a person who is on leave of absence from or who has deferred enrolment in a module or program of DLI.
